"Mrs. Dix Prepares Index Of Early County Records

An index to the early records of the county has been compiled by Mrs. Ray Dix of Esgar Avenue, who personally scrutinized the documents, many of them in faded Spencerian script, to complete the work. It has been presented to the McHenry Public Library by the Major Hugh Moss chapter, Daughters of the American Revolution.

The 378 page book, *Early Records Of Stanislaus County*, includes marriages from 1854 to 1905 and abstracts of wills from 1872 to 1905. Following a section on marriage records, Mrs. Dix has included an index of brides in order that a researcher, knowing only the wife's maiden name, will be able to find her married name and the marriage certificate.

A section on Will abstracts is augmented by an index including each heir and witness."
